BIDDER DECLARATION OF NON-AFFILIATION

I, _____, pursuant to 28 U.S.C. §1746, declare under penalty of perjury that the below is true and correct:

1. I make this declaration upon my own personal knowledge, either individually or in my capacity as duly authorized representative of _____ (“Potential Bidder”), I am personally familiar with, and competent to testify as to, the matters set forth hereto, and am otherwise *sui juris*.

2. I submit this declaration in support of Potential Bidder’s desire to participate in the auction sale of the assets of Today’s Growth Consultant, Inc. (d/b/a the Income Store) (“TGC”) that are currently part of the Receivership Estate (“Assets”).

3. I represent that neither Potential Bidder, nor any of its shareholders, members, directors, officers, managers, employees, agents, partners, or associates, is

- (a) related by blood or marriage to Kenneth D. Courtright, III (“Courtright”) or any member of Courtright’s family (including, but not limited to, Kerri Courtright or William Courtright), or
- (b) acting in concert with Courtright or a Courtright family member in any business venture, or
- (c) a former officer, director, or manager of TGC including but not limited to Michael Engstrom, Ronald Fossum, David Conklin, William Longcore, Cody Neer, or one of their respective family members, or
- (d) EIN Cap, Inc., Alpha Capital Source, Inc., BMF Capital, LLC, FundKite, LLC, AKF, Inc, World Global, LLC, Fox Capital Group, Inc., High Five Group, LLC, and Sutton Funding NY, Inc., or a shareholder, member, officer, director or manager of one of those companies.

4. I further represent that other than Melanie Damian, as Receiver, if the Potential Bidder is the winning bidder of the auction sale for the Assets, Potential Bidder will not bestow any money or other consideration in connection with the auction sale of the Assets, or any interest or acquisition right in the Assets, upon:

- (a) Courtright, nor any member of Courtright’s family (including, but not limited to Kerri Courtright or William Courtright);
- (b) any person or entity in any manner currently affiliated with Courtright or any member of Courtright’s family;

- (c) any other person currently acting in concert with Courtright or a Courtright family member;
- (d) any former officer, director, or manager of TGC; or
- (e) any person or entity listed in Paragraph 3 above.

5. Finally, if Potential Bidder is the winning bidder of the auction sale for the Assets, Potential Bidder represents and agrees not to employ or contract with Courtright, any member of Courtright's family, any former officer, director, or manager of TGC, or any person or entity listed in Paragraph 3 above in connection with use, management, or sale of the Assets.
